CONDITIONS GOVERNING THE ACCEPTANCE OF ITEMS FOR EXAMINATION BY THE MEPSI EXPERT COMMITTEE

- Application blanks can be downloaded from WWW.MEPSI.ORG or will be supplied upon request when accompanied by a SASE. All requests for examination must be accompanied by a completed application and payment of fees.
- Applications are treated in a first-in, first-out basis.
- Applications must be delivered to the MEPSI Expert Committee address on the front page of this application.
- All material submitted to the committee will be insured for its fair market value up to \$15,000 for material sent to US addresses or to foreign addresses for a single loss while in possession of the Administrator, in transit to and from examiners, and while being returned to the applicant. The value assigned will be the responsibility of the Administrator and may not be that indicated by the applicant. Combined material in excess of \$15,000 must be sent by separate package.
- MEPSI seeks to render a service in the expressing of opinions of qualified philatelists on items submitted to it. The fees set forth herein are intended to defray the expenses incurred for the operation of the Expert Committee. However, opinions given by the Expert Committee are not guarantees, and MEPSI, its officers, agents, committees and employees shall not be in any way liable for loss or damages resulting from opinions given.
- Applicants should indicate a recommended FAIR MARKET VALUE for each item submitted. If this value is considered to be unrealistic by the Administrator it will be adjusted to reflect the more realistic value. This assigned value will be used for insurance coverage which is limited to \$15,000 USD for material. If a value is not listed, value in case of loss will be considered to be zero.
- The Committee will accept for examination stamps and other philatelic material of Mexico only. It also reserves the right at all times to decline to examine or provide opinion on any item. This does not prejudice an applicant from requesting the Committee's opinion on the same item at some future date.
- MEPSI, and its Expert Committee reserves the right to make such changes in the rules, conditions or fees as they deem necessary without advance notice. Such changes will be announced as soon as possible.
- The request for an examination constitutes acceptance of the foregoing rules, conditions or fees. Applicants desiring their name be omitted from the certificate should so indicate by checking the box provided on the front page of this form.
- Certificates remain the property of the MEPSI Expert Committee.
